Opinion

Emphasis of Matter – Restriction on Distribution

The statement is prepared to assist the **H.H Misbah Securities (Private) Limited** to meet the requirements of the SECP, Pakistan Stock Exchange (PSX) and National Clearing Company of Pakistan Limited (NCCPL). As a result, the statement may not be suitable for another purpose. Our report is intended solely for **H.H Misbah Securities (Private) Limited**, SECP, PSX and NCCPL and should not be distributed to parties other than **H.H Misbah Securities (Private) Limited**, or the SECP, PSX or NCCPL. Our opinion is not modified in respect of this matter.

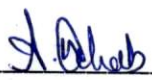
